Shelton Police make 11 Arrests in Statewide Warrant Operation

On July 18, 2018, after several months of planning, over 90 municipal, state, and federal law enforcement agencies in Connecticut executed a "Statewide Warrant Sweep Operation". The operation commenced pre-dawn with each participating agency conducting sweeps for wanted persons within their jurisdiction.

The targets of this operation were individuals who are currently wanted on felony and misdemeanor outstanding arrest warrants. In total, this operation netted **267** arrest warrants being served statewide.

The Shelton Police Detective and Patrol Divisions participated in this operation. The Shelton Police Department arrested 11 individuals during the operation. Arrested were:

52 year old Jozef Waclawik of Shelton who was charged under two separate arrest warrants for Failure to Appear 2nd Degree. Jozef was unable to post and was transported to Derby Court.

52 year old John Inderdohnen of Shelton who was charged with Failure to Appear 2nd Degree and posted a \$500 bond. John was released and given a court date of 08/01/2018.

78 year old Michilene Gagstetter of Shelton who was charged with Failure to Appear 2nd Degree and posted a \$2,500 bond. Michilene was given a court date of 08/01/2018.

83 year old Frank Lawson of Shelton who was arrested and charged with Failure to Appear 2nd Degree and posted a \$500 bond. Frank was given a court date of 08/01/2018.

43 year old Colleen Ann Daly-Williams of Shelton who was charged under three separate arrest warrants for 2 counts of Failure to Appear 2nd Degree and 1 count of Failure to Appear 1st Degree. She posted a total bond of \$4,000 and was given a court date of 08/01/2018.
